BUDGET PUBLIC HEARING

Call to Order: Chairperson Tom Winker called the Public Hearing to order at 7:00 pm. Pledge of Allegiance recited.

Proposed 2020 Budget: The proposed 2020 local levy is \$461,511; a 0.5% increase of the 2019 local levy of \$459,405. Don Feyereisen and Tom Petersen questioned the increase even though the town hall loan was paid off this year. The 2020 budget reflects an increase in the transfer of recyclable materials and a new expense for ambulance service from the Fredonia Fire Department. Anticipated road projects were discussed and will be determined in the annual spring road inspection.

Electors to Adopt Road Expenditures: The proposed 2020 road budget is \$379,530. Road projects were discussed again. Tom Winker informed of a 90/10 grant which, if granted, will aid in paving of two miles of Jay Rd. The town would be required to pay 10% of the project. Chip sealing, which is effective on roads with lighter traffic, costs approximately \$18,000 per mile. Paving costs approximately \$150,000 per mile.

Transfer Site Update: Michael Thun will be attending the December town board meeting to discuss material transfer increases beginning January 1st.

Schimberg Land Division/Rezone: David & Mary Schimberg to separate and rezone from A-1 to A-2 3.6 acres with structures at 6704 Lone Elm (01-009-03-003.00). The remaining 6.4 acres will be combined with 26.46 acres at 6718 Lone Elm (01-009-03-002.00). The 6.4 and 26.46 parcels would also be combined with the 39.98 acre parcel to the west (01-009-05-001.00) for ordinance compliance. Motion Winker/Bichler to approve the request Motion carried unanimously.

2020 Budget: Motion by Janeshek/Bichler to approve the 2020 budget as presented; motion carried unanimously.

McClaren Height Modification: Brian McClaren to construct an accessory structure 19 ft. & 2 in. (exceeding allowable height of 15 ft.) at 6618 Silver Beach North (02-007-09-012.00). Plan Commission favorable recommendation on October 9, 2019. <u>Motion Bichler/Janeshek to approve the height modification; motion carried unanimously.</u>

Election Security Grant: Motion Winker/Bichler to approve the Memo of Understanding between the Town of Belgium and WI Elections Commission; motion carried unanimously.

Water Issues – Homestead Drive: Ongoing water issues were discussed. The Board will investigate during road inspection road inspection in spring.

Citizen Input: Concern of trees in right of way on Silver Beach.

Audit Bills: Monthly invoices were audited and ordered paid.
